INTRODUCTION

Development of the multitype library system begins with the concept of establishing partnerships among the four library sectors in the province: postsecondary, public, school and special libraries. A multitype library system is a cooperative system in which any two or more types of libraries participate to deliver library service. The Provincial Library will also be one of the partners and the partnership may be extended to include other information providers in any community.

Part I of the strategic plan outlines the course for future development of libraries in Saskatchewan. The Multitype Library Development Advisory Committee hopes that this document will be circulated widely among all the potential partners, stakeholder groups and the broader community.

Part II is structured as a workbook and contains the detailed implementation plan. It is intended as a working document for libraries and other partners to use as they build their part of the multitype library system.

The left hand page lists the strategy and the action as well as a brief explanation of the Advisory Committee's thinking behind creation of the action.

The right hand page repeats the strategy and action statements in their briefest form and identifies what specific activities should be undertaken, who should do them and when should they be done. Actions for which either the Multitype Library Board (MLB) or Provincial Library (PL) are responsible, are identified. The Committee suggests that partners look at the action necessary at the provincial level and determine if there is a comparable action which would be appropriate at the local level.

The Notes portion of the page is provided for potential partners to record the action steps to be taken locally.

PART II MULTITYPE LIBRARY SYSTEM WORKBOOK

GOAL 1:

DEVELOP THE MULTITYPE SYSTEM

OBJECTIVES:

1. Strong independent libraries and communities, working in partnership, will ensure the successful development of a multitype library system.
2. Other information providers will be integral partners in the multitype library system.

STRATEGY 1:

To establish a Multitype Library Board to facilitate the cooperative development, maintenance and evaluation of the multitype library system.

ACTION 1: Appoint a Multitype Library Board representative of the constituent groups and employ participatory decision-making. Proposed representation:

4 library directors, one from each library sector [public, special, school (Saskatchewan School Libraries Association, subject council of the Saskatchewan Teachers Federation*), post-secondary]

1 Provincial Librarian

1 Saskatchewan Library Association *

2 additional representatives from special and postsecondary - for a minimum of 2 representatives from each of the four sectors

1 Saskatchewan Urban Municipalities Association *

1 Saskatchewan Association of Rural Municipalities *

2 members - consider criteria necessary for balance - north/south, urban/rural, governance/operational - or interests - Indian and Métis, gender, users

* Organizations will be asked to submit three names from which the member can be chosen. All other appointments will be made by the Minister in consultation with the broader community.

A board which brings together people from the various types of libraries is necessary because, under existing structures, there is no place which currently brings together representatives of the 6 partners and the key stakeholders. The Multitype Library Board (MLB) will represent the four library sectors as well as have representatives from the key stakeholders and other potential partners.

Key stakeholders include library and school trustees, the professional associations for library workers in Saskatchewan, and others responsible for the management of libraries. Other information providers may include: organizations like museums and archives; government agencies such as research centres, rural service centres, business information centres; associations including cultural groups and freenets; and any other individual or organization that provides information for free dissemination or sale. Representatives on the Board may be chosen based on current initiatives of the Board. For example, if there is a project underway to network library and museum databases,

the other information provider position may be offered to a museum representative.

ACTION 2: Review and implement the Terms of Reference for the Multitype Library Board.

Proposed Terms of Reference:

1. The mandate of the Board is to implement the Strategic Plan prepared by the Multitype Library Development Advisory Committee.
 2. The Board will receive and consider the results of the consultations carried out by the Interim Multitype Library Development Advisory Committee and its sub-committees.
 3. In the first year, the Chair will be appointed by the Minister from the members. The committee should determine its own chair for succeeding years on an annual basis.
 4. All positions will be for 2 years. In the first year half the positions will be appointed for 3 year terms and half will be for 2 years. Half the positions will change each year. Members may serve a maximum of 2 terms.
 5. The secretariat to the board will be the Provincial Library.
 6. Members' expenses will be paid.
 7. Honorariums will be provided to association representatives. Library staff will receive honorariums only if replacement staff are required.
 8. The full Board shall meet at least 3 times a year.
 9. The Board may establish its own rules of operation including creation of an Executive Committee and sub-committees as required.

The terms of reference for the Board recommended by the Advisory Committee set out the mandate and operating conditions of the Board and are designed to obtain maximum participation by potential partners, to foster communication with the partners and stakeholders and to allow the Board to operate as inexpensively as possible.

The Advisory Committee or its sub-committees may consult with the community on the Strategic Plan and may make recommendations to the new Multitype Library Board based on those consultations.

The Board has been given a large task in the strategic plan. They may not be able to conduct all of the necessary business at meetings of the full board. Provision has been made to create subcommittees which will work on specific tasks or projects. The Provincial Library (PL) will continue to serve as the secretariat to the Multitype Library Board (MLB).

ACTION 1: Work with other interested groups to promote libraries in a multitype library system.

Special needs groups may include people with disabilities, ethnocultural groups, people who lack literacy skills and others who have difficulty using standard library services. The best way to ensure participation in the multitype library system is to involve as many groups as possible in the planning stages. This also ensures that plans will be made taking into account the needs of special target groups.

ACTION 2: Facilitate the development of cooperative collection policies in order to:

- increase the breadth and depth of materials available
- share resources for special services and collections in all libraries in the province
- prevent unnecessary duplication

Establishing a database to serve as a clearinghouse for information relevant to multitype library system development is identified as a strategy later in this document. Information about library collections could be assembled by Provincial Library, entered into this database, and made available to all partners. Participants can be involved in maintaining the integrity of the information on the database.

Development and maintenance of the database would be a significant expense but collection and dissemination of information was seen as a key strategy for the implementation of a multitype library system.

ACTION 2: Facilitate the development of cooperative collection policies in order to:

ACTION 3: Encourage and facilitate libraries to work together to realize cost savings through joint ventures.

Participants may have ideas for joint ventures and they would be able to mount the information on the clearinghouse database. This would allow others to react to the information, suggest modifications, and eventually join the venture if appropriate. Such opportunities should be actively sought out and advertised as widely as possible among those most likely to benefit from them.

ACTION 4: Encourage all libraries and communities of interest to plan within the context of the multitype system and facilitate sharing of those plans.

Ideally each autonomous library will begin to think in terms of operating in a multitype library system milieu. They will make long and short term plans with multitype issues always influencing their decisions.

No action plans should be made that would prevent future cooperation even if no obvious cooperative choices present themselves today. Plans which library systems make, that do have a multitype component, should be shared with all other library systems, again making use of the clearinghouse database.

ACTION 5: Cooperate with Indian and Métis peoples to define their participation in the multitype library system, when they see their involvement as separate from any of the four sectors (postsecondary, public, special and school). Facilitate their participation in the system.

With current developments in Indian self-government it is not clear how library services for First Nations and Métis people will develop. In any event, the Multitype Library Board wants to clarify that participation by Aboriginal people is desirable and that they have the right to determine how that participation will be manifested.

This intent should be communicated as widely as possible to ensure that Indian and Métis people are able to determine how and when it is appropriate for them to participate.

Communication of the Strategic Plan is a key strategy for development of the multitype library system. This information should be part of the Communication Plan which will be developed as part of the overall strategy.

To involve all libraries and communities of interest in the cooperative development, maintenance and evaluation of the multitype library system.

GOAL 2:

IMPLEMENT A MULTITYPE LIBRARY SYSTEM

OBJECTIVES:

1. Libraries will have effective mechanisms in place for sharing resources including human, physical and technical resources among all libraries throughout the province.
2. Saskatchewan residents will have access to all libraries in the province.
3. Information needs of Saskatchewan residents will be met by strong libraries with appropriate staffing, funding, resources, and facilities.
4. A sustainable multitype library system will be strengthened by ongoing formal evaluation by all of the partners.

STRATEGY 3:

To conduct ongoing research about multitype library systems.

ACTION 1: Collect and disseminate statistical and demographic information required for the development and maintenance of a multitype library system.

All libraries collect statistics of various sorts about their operations. Many report statistics to an agency which collects statistics for like libraries, for example, Provincial Library collects information for all public libraries in Saskatchewan; the Universities contribute statistics to the Council of Prairie Universities.

However, it is currently no one library's job to collect statistics which relate to the services of all types of libraries. These statistics would not normally be collected, compiled or analyzed, yet they will be needed as a multitype function. That will become a function of the Multitype Library Board through its secretariat Provincial Library.

Provincial Library will use the clearinghouse database to record, analyze and disseminate statistical information which is necessary to develop and maintain the multitype system.

ACTION 2: Develop and maintain a clearinghouse for information concerning multitype library initiatives.

Provincial Library should begin immediately to develop a database to serve as a clearinghouse for multitype library system information. This is information which does not relate to any one library or type of library but rather to libraries which come together in a multitype system.

Information is key to this endeavour and being able to access that information in the most effective manner possible will be important. Many areas of development will require this type of clearinghouse information, from book collections to library statistics to technical requirements for database connectivity.

The cost of developing and maintaining such a database will be significant.

ACTION 3: Conduct a five year review of multitype library system.

Evaluation of the success of a project is an important component of developing and maintaining a viable, effective and efficient service. An independent evaluation should take place after five years of sustained effort towards development of the multitype library system.

This evaluation may lead to recommendations for a new strategic plan or only modify slightly the path libraries are already on in the province. In any case, evaluation needs to be done to ensure continued effective development.

ACTION 4: Identify materials and collections in the province that have regional, provincial or national significance and ensure access to them is preserved for Saskatchewan residents.

Provincial Library and any of the partners may identify books and other library materials which are important to the people of Saskatchewan, Canada and beyond. The Multitype Library Board should have the mandate and authority to recommend preservation of such materials in some appropriate manner or at least provide some options to ensure that access to significant materials is preserved.

ACTION 4: Identify materials and collections in the province that have regional, provincial or national significance and ensure access to them is preserved for Saskatchewan residents.

ACTION 1: Develop a set of protocols for the multitype library system.

In order for the multitype library system to operate effectively, protocols will need to be established for library functions. The Multitype Library Board needs to take responsibility for development of such protocols in consultation with the library community, and for the ongoing updating, revision, renegotiation and other maintenance of those protocols.

Participating libraries need to adhere to standards of operation to be effective participants in the multitype library system. Standards will need to be developed for all operational aspects of library service: bibliographic records, interlibrary loans, document delivery, human resources allocation and training, development and maintenance of library materials and collections.

The Board may need to continue development of standards as long as there are other functional areas which require standards to be developed. This process may happen over a period of many years.

Ability to do more with the resources available is one of the driving forces behind establishment of the multitype library system. Individual libraries will be able to save money through shared services and resources. The Committee is concerned that the system not require a great deal of additional funding. At the same time, it is necessary to realize that the work outlined will require funds. Ways must be found to assure such funding.

Staff will require training to help them determine how operating in a multitype context should be different. The Multitype Library Board can play a role in assisting this process.

STRATEGY 7:

ACTION 1: Train and educate staff in the delivery of services within the context of a multitype library system particularly for operational changes in areas such as: protocols, standards, attitudes, or technology.

Coordinating training opportunities may require no more effort than simply informing library personnel about what is available and letting local people organize their own participation. This task may easily be accomplished through the clearinghouse.

Together the Provincial Library and the Board may determine that it is necessary to take more formal steps to assess training needs.

GOAL 3:

CONNECT LIBRARIES OF ALL TYPES TO PROVIDE EQUITABLE ACCESS TO AND DELIVERY OF INFORMATION

OBJECTIVE:

1. The connection of libraries will provide the mechanism to ensure province-wide resource sharing that is affordable, fast, current, and distance neutral.

STRATEGY 8:

To develop a Province-wide Library Electronic Information System (PLEIS).

ACTION 1: Coordinate the collection of information on computing and telecommunications technology.

Library staff need information technology and telecommunications information to guide their network development at the local level. Information can be made available through the clearinghouse. Participants may also contribute their own information and experience to the database.

The Multitype Library Board, Provincial Library and the participants themselves need to be involved in developing the network.

The potential partners in the multitype library system are the four library sectors, Provincial Library and other information providers. These partners are already well informed about many library science and technology issues. What is needed for this group is to ensure that there is regular communication of pertinent information about how libraries operate within a multitype environment. This can be achieved through development of a communications plan.
